GCC's current program areas of focus are home energy efficiency, green infrastructure, and sustainable transportation.

The Position:

Are you an experienced Registered Energy Advisor looking to support core EnerGuide services at a national environmental non-profit? GCC seeks a Quality Assurance Manager to work with our Service Organization Manager to support our growing residential energy services using our EnerGuide Rating System license with Natural Resources Canada (NRCAN). This position will take on progressive responsibilities including QA, technical systems management, and EA training. They may also support with GCC's new deep energy retrofit program activities.

Key Responsibilities:

This position will progressively lead the following activities. Training will be provided on an ongoing basis, with greater responsibility being assumed over time.

- **Quality Assurance for EnerGuide Submissions:**
 - Provide ongoing technical support to GCC's network of REAs, through telephone and email
 - Conduct Level 2 and 3 QA on ERS files
 - Support NRCAN's 3rd party QA reviews.
- **Management of EfficiencyWorks:** Based on GCC's needs, changes to NRCAN systems, or evolving incentive programs, the QAM will update functionality, design new features, and work with GCC's developer to test and deploy them.
